No. /3239/CHSE/The following Clauses are hereby added to the Alternative Assessment Criteria for Regular & Ex-Regular Examinees of Annual H.S. Examinations, 2021 notified earlier vide Notification No. 2526/dt. 18.06.2021 as per the recommendations of the Examination Committee.

Clause: 1

If a candidate has been enrolled with Language Papers which he/she had not taken in the Class-X Board Examination, then, the average percentage of marks secured by him/her in the Language Papers shall be taken as mark in the Language Paper(s) for which marks are not available.

Clause: 2

If the marks in any Elective or non language subject/paper is not available in the Class-X Board mark sheets of any examinee, then the average marks in the non language papers shall be taken into consideration and the average mark thus calculated shall be taken as the mark in that paper/subject for which mark is not available.
