In exercise of the power conferred under Section 11(e), (f), (g) & (h) of the Odisha Secondary Education Act - 1953 as amended in 1979 & 1996, the General Body of the Board in its meeting held on 18/08/2017 vide Resolution No -02 have decided to

conduct SIOS Exam at par with HSC Examination as noted below

1. Individual subject wise pass mark will be 30% instead of 33%.
2. Aggregate pass mark will be 33%
3. Objective type question (50 marks) shall be introduced in OMR Answer Sheets
4. The rest 50 marks will be subjective questions as that of HSC Examination
5. Rechecking of marks for SIOS candidates will be applicable as in the HSC Examination.
6. The certificate of the students of the SIOS Examination shall be treated at par with HSC Examination certificate until further orders. These modifications shall be reflected in the regulation for conduct of Odisha State Open School Certificate Examination with immediate effect.


